ANNEXURE – A

The Association shall for the time being consist of following categories of Members as mentioned below :

- i) **ORDINARY MEMBER :** Any person, firm, company, corporation duly registered as a Small Scale Industry with appropriate Govt. authority, for manufacturing, formulating / processing of pesticides in India, shall be eligible to become an Ordinary Member of the Association.
- ii) **ASSOCIATE MEMBER :** Any firm / company / corporation / person engaged in Manufacture / Formulate pesticides, other than small scale sector and engaged in Dealer / Distributor of pesticides, supplier of packaging material and / or machinery to Pesticides Industry shall be eligible to become an Associate Member of the Association.
- iii) **PROFESSIONAL ASSOCIATE MEMBER :** Representative of Educational Institution, Govt. Department, Professional Technicians, Consultants directly connected with the Pesticides Industry or with Agricultural advancement.

**B. MEMBERSHIP AND ENTRANCE FEES :**

The Entrance Fees payable for different categories shall be as under :

Categories of members of the Association shall be as under :

- i) **Ordinary Member :** Rs. 5,000/- per annum. Having turnover above 2.5 crores per year.  
  
However, if a member whose Annual turnover is less than Rs. 2.5 crores may notify & if the Managing Committee is satisfied with the documentary evidence then the Annual Subscription payable in respect of such member shall be Rs. 2,500/-
- ii) **Associate Member :** (i) Rs. 4,000/- for members who are manufacturers / formulators other than small scale  
  
(ii) Rs. 2,500/- Those who are other than Manufacturers of Pesticides
- iii) **Professional Associate Member :** Rs. 2,000/- per annum.
- iv) **Affiliated Member :** Rs. 3,500/-
- v) **Honorary Member :** Nil

Provided further that the Managing Committee will have the right to recommend changes in the above, subject to the approval of the Members in General Meeting.
